

2023 driving law changes

As we enter the New Year it is worth reviewing the major changes to driving and vehicle law which are either now operating or will become part of the law this year:

1. ULEZ expansion

In late August 2023, Ultra Low Emission Zone is set to undergo its third expansion, and is likely impact thousands more drivers in its wake. At present, ULEZ covers all areas within the North and South Circular roads, but will soon extend to all of the city's 33 boroughs and those whose vehicles do not meet ULEZ emissions standards, will have to pay a £12.50 daily charge to drive inside the zone.

You can use the Transport for London website to check if your vehicle is exempt here: https://tfl.gov.uk/modes/driving/check-your-vehicle/

Some of the outer London boroughs oppose this change and may refuse permission for the required CCTV cameras installation on their roads. This could be interesting!

2. Number plates

Rules on the appearance of number plate lettering changed last year – and those rules will stay in place until the latest numbers are announced in March 2023.



The number plates on your vehicle must:

- be made from a reflective material
- display black characters on a white background (front plate)
- display black characters on a yellow background (rear plate)
- not have a background pattern
- be marked to show who supplied the number plate
- be marked with a British Standard number this is 'BS AU 145e' for plates fitted after 1 September 2021

The characters must not be removable or reflective. If your number plates were fitted after 1 September 2021, they must also be a single shade of black.

Your number plates can also:

- have 3D (raised) characters
- display a green flash, if you have a zero-emission vehicle


UK stickers have replaced the old white oval GB stickers. If you have a GB sticker, cover or remove it before driving outside the UK.

• Do not put the sticker on your numberplate.

3. Fuel duty rates

UK fuel duty rates were slashed by 5p for 12 months to help struggling families manage the soaring price of fuel alongside other rising household costs.

On 23 March 2023, however, this reduction will end, and the Office for Budget Responsibility (OBR) has suggested that fuel duty may increase.





4. Benefit in Kind (BiK) rates

Benefits in Kind (BiK) are goods and services provided to an employee for free or at greatly reduced costs on top of their salary and those furnished with a company car must pay a BiK contribution – which is more commonly referred to as a company car tax.

As it stands, a petrol car which produces 100g/km emissions pays 25 per cent BiK compared with just 13 per cent in 2013.

The government has said rates will remain frozen until April 2025 in the hopes of encouraging employees to opt for electric vehicles.

5. TfL Scrappage scheme

From 30 January 2023, Londoners receiving certain disability and means-tested benefits will be able to apply to TfL's car and motorcycle scrappage scheme. Beneficiaries can receive a grant



payment, or a grant payment plus one or two Annual Bus & Tram passes.

A separate van and minibus scrappage scheme will also be available for sole traders, micro-businesses (10 or fewer employees) or charities and there will also be ULEZ support offers for successful scrappage scheme applicants as well as offers for all Londoners to take advantage of, whether eligible for a grant or not.

6. Parking on pavements in Scotland

Scotland's delayed implementation of its ban on pavement parking and dropped kerbs is set to be enforced this year. Though the move was announced in 2019 its implementation was pushed back due to the pandemic.

7. Heavy goods vehicle levy

Heavy goods vehicles weighing over 12 tonnes are charged a levy cost of any damage or wear they inflict on British roads. The levy was suspended for UK-registered HGVs during the pandemic, and extended for another year in August 2022. This suspension will be lifted in August 2023, meaning freight companies will start paying the extra costs again.

8. Excise Duty for electric car owners

Chancellor Jeremy Hunt announced in his autumn statement that zeroemission vehicles will lose their vehicle excise duty (VED) exemption from



April 2025. Owners of EVs who currently pay no VED will face an annual charge of up to £165 for cars and £290 for vans. The Treasury said the changes are estimated to raise an extra £1.6 billion by 2027/28.

Advanced Driving for All

IAM RoadSmart recently announced that last year 2,064 people passed the Advanced Driving Course, including 930 passing with a F1RST. This is a fantastic achievement and a welcome return to normal service after the pandemic and the suspension of on road coaching at key moments in 2020 and 2021.

Being a part of the largest independent road safety charity in Britain has many benefits for IAM RoadSmart members. If you passed your Advanced Driving Course several years ago you can book a refresher session through TVGAM and/or take a member's reassessment through IAM RoadSmart with one of our Examiners. You might also want to consider fellowship membership whereby you will be retested every three years to ensure that your driving is at advanced standard and that you are not experiencing skill fade. In addition, IAM RoadSmart offers the Masters test for those members who want to obtain the highest civilian driving standard in the country.

IAM RoadSmart also offer the opportunity for you to train as an Observer to pass on your advanced driving knowledge and skills to new members who join the organisation. By April 2025, all Observers will be trained and assessed to National Observer standard. In preparation for this change within IAM RoadSmart, TVGAM has put in place a bespoke training package to help our own Observers to prepare for the National Observer Assessment (NOA).

This all represents very good value for money, especially when you compare it to a typical track day that can cost anything between £150 and £500 per day (depending on the track, time of year and other factors). If we did not have charities like IAM RoadSmart, advanced driving would be very expensive and elite. The Advanced Driving Course is not cheap but then again neither is owning and driving a vehicle. I recently spent £300 on a relatively good quality motorbike helmet that will last anywhere between three and five years before it will need to be replaced.

The other main benefit of membership of IAM RoadSmart is access to our publications. I re-read the Autumn/Winter edition of RoadSmart (the magazine that is free to members of IAM RoadSmart). It was packed full of excellent articles from driving down the cost of motoring to the big EV debate and insights into Police escort driving. Driving (and riding) is by far the biggest risk that many of us undertake on a daily basis. Investing in knowledge and skills to keep us safe on the roads is money well spent.
